- ፩) **“ባለሥልጣን”** ማለት የኦሮሚያ ክልላዊ መንግሥት መስኖ ልማት ባለሥልጣን እና በየደረጃ ያሉትን መዋቅሮችን የሚጨምር ነው፡፡
- ፪) **“መስኖ መሠረተ ልማት እና ባህላዊ የመሬት ማንጣፈፍ አውታር”** ማለት አርሶ አደሮች፤ አርብቶ አደሮች ወይም ከፊል አርብቶ አደሮች በልምድ ባገኙት ዕውቀት በአካባቢ የሚገኙ ማኅበራትን በመጠቀም የሚገነባ ማለት ነው፡፡

WHEREAS, it is found necessary to establish system where by the associations be established for the purpose irrigation service and development and land drainage independently in the Region;

WHEREAS, it is found necessary to establish a system whereby controlling relationship to be made between service delivery and service provider to extend an advanced irrigation water administration; by extending whereby the schemes administration, irrigation developments and land drainage built by the Government, Non-governmental or the society to be transferred to irrigation water users associations;

NOWHEREFORE, in accordance with the revised Oromia Regional State constitution No.46/2002 of Article 49 (3) (a), the following is hereby proclaimed.

Part One General Provisions

1. Short Title

This Proclamation may be cited as “A Proclamation to Determine Irrigation Water Users Association of Oromia Regional State-Proc. No.204/2017”.

2. Definitions

Unless the context requires otherwise, in this Proclamation:-

1. **“Authority”** means Oromia Regional State Irrigation Development Authority and its structures.
2. **“Traditional Irrigation Development and Land Drainage Bases”** means an irrigation and land drainage constructed by farmers, pastoralists and agro-pastoralists using their own indigenous knowledge by locally available materials.

- 3) **“Bu’uura Misooma Jallisii fi Qoor-sa Lafa Ijoo”** jechuun bishaan misooma jallisii gara daangaa waldaa tokkootti yookiin tokkoo olitti geessuuf kan tajaajilu jechuudha.
 - 4) **“Bu’uura Misooma Jallisii fi Qoorsa Lafaa”** jechuun ijaarsa misooma jallisii, bishaan misooma jallisii bakka argama bishaanii irraa fuudhee gara maasaatti geessu kan akka bo’oo yookiin ujummoo fi iskiimota yoo ta’u, kanneen waliin kan wal qabatan laga dabsuuf kan gargaaran hidha, kuusaa bishaanii yookiin haroo akkasumas balbala bishaanii misooma jallisii keessa darbu kamiyyuu kanneen akka paampii, lafa, gamoo, meeshaalee adda addaa, daandii akkasumas bu’uuraalee misooma jallisichaa hojjiirra oolchuuf, haaromsuuf yookiin suphuuf kan gargaaran hunda kan dabalatu jechuu dha.
 - 5) **“Bu’uura Misooma Jallisii fi Qoorsa Lafa Hammayyaa”** jechuun jallisii fi qoorsa lafaa qorannoo fi dizaayiniin isaa haala hammayyaatiin hojjatame yookiin hammayyaa akka ta’u kan taasifame jechuudha.
 - 6) **“Daangaa Tajaajilaa”** jechuun daangaa lafaa murtaa’aa waldaaleen itti fayyadamtoota bishaan jallisii itti fayyadaman jechuudha.
 - 7) **“Federeeshinii”** jechuun waldaaleen itti fayyadamtoota bishaan jallisii lamaa fi isaa ol ta’an bakka tokko irraa dhiyeesa bishaaniitti fayyadamaanii fi bu’uuraalee misooma jallisii fi qoorsa lafaa bulchuu fi suphuuf akkaataa Labsii kanaatiin itti gaa-fatamummaa kan qabu jechuudha.
 - 8) **“Galmee”** jechuun Abbaa Taayitichaatii fi caasaa isaa sadarkaan jiruun kan qabamu galmee ragaalee waliigalaa fi qaama seerummaa waldaa itti fayyadamtoota bishaan jallisii kan ibsu jechuudha.
- ፫) **“የመስኖ መሠረተ ልማት እና ዋና የመሬት ማንጣፈፍ አውታር”** ማለት የመስኖ ልማት ውሃን ወደ አንድ ወይም ከዚያ በላይ ወደሆነ የማኅበር ድንበር ስመዉሰድ የሚያገለግል ማለት ነው።
 - ፬) **“የመስኖ መሠረተ ልማት እና የመሬት ማንጣፈፍ አውታር”** ማለት የመስኖ ልማት ግንባታ፣ዉሃ ከሚገኝበት በመውሰድ ወደ ማሳ የሚወስድ አንድ በይ ወይም ተጠቃሚ እና ስኪሞች ሲሆን ከነዚህ ጋር የተያያዙና ወንዝን ስጥሰፍ የሚያገለግለው ግድብ፣ የውሃ ማጠራቀሚያ ወይም ኩሬ አንዲሁም ማንኛውም የመስኖ ልማት ውስጥ የሚያስፈልግ የውሃ በር አንድ ፕሞፕ፣ መሬት፣ ሕንፃ፣ የተሰዋዊ መሳሪያዎች፣መንገድ አንዲሁም የመስኖ ልማትን መሠረተ አውታሮች ተግባር ላይ ስማዋስ፣ ስማደስ ወይም ስመጠገን የሚረዱትን ሁሉ የሚጨምር ማለት ነው።
 - ፭) **“የመስኖ ልማት አውታር እና ዘመናዊ የመሬት ማንጣፈፍ”** ማለት ጥናት እና ዲዛይን በዘመናዊ ሁኔታ የተሰራ ወይም ዘመናዊ አንዲሁም የተደረገ ማለት ነው።
 - ፮) **“የአገልግሎት ወሰን”** ማለት የመስኖ ዉሃ ተጠቃሚዎች ማኅበራት የሚገለገሉበት የተጠ ወሰን የመሬት ወሰን ማለት ነው።
 - ፯) **“ፌዴሬሽን”** ማለት ሁለትና ከዚያ በላይ የሆኑ የመስኖ ውሃ ተጠቃሚዎች ማኅበራት ከሚጠቀሙበት ከአንድ ውሃ አቅርቦት የመስኖ ልማት አውታሮች፣ የመሬት ማንጣፈፍ የማስተዳደር እና ስመጠገን በዚህ አዋጅ መሠረት ኃላፊነት ያለበት ማለት ነው።
 - ፰) **“መዝገብ”** ማለት በባለሥልጣኑ እና በየደረጃ ባለው መዋቅሮች የሚያዝ የአጠቃላይ መዝገብ መረጃ እና የመስኖ ውሃ ተጠቃሚዎች ማኅበራት የህግ ሰውነት የሚገልፅ ነው።
3. **“Major Irrigation Development and Land Drainage Basis”** means an irrigation and drainage system that can be used to transmit water to the service areas of one or more associations.
 4. **“Irrigation Development Bases and Land Drainage”** means a canal or a system of canals or pipes that can be used to transmit water to a defined land area for irrigation including any associated weir, dam or diversion structure, storage reservoir or pond as well as any gates, pumps, land, buildings, equipment, access roads and structures which are necessary to operate, maintain and repair the system-together with any associated drainage canals.
 5. **“Irrigation Development Bases and Modern Land Drainage”** means irrigation and land drainage constructed on the basis of a formal study and design or a modernized irrigation and land drainage system.
 6. **“Service Area”** means the defined land area where the association operates;
 7. **“Federation”** means an association formed by two or more irrigation water users association that can use irrigation water from the same source and which have responsibility to administer and maintain irrigation infrastructure and land drainage system have responsible according to this proclamation.
 8. **“Registry”** means a book necessarily owned by Oromia irrigation development authority and its structures used to record general information and legality certificate of Irrigation water users association.

- 9) **“Koree Hojii Raawwachiiftuu”** jechuun qaama sochii hojii waldaa tokkoo akka hordofuu fi to’atuuf yaa’ii waliigalaa hundeesitoota waldichaatiin kan filatamaniidha.
 - 10) **“Kutaa Lafaa”** jechuun daangaa waldaan tokko tajaajila kennu keessatti lafa argamu jechuudha.
 - 11) **“Madda Dhiyeessii Bishaanii”** jechuun madda bishaan itti argamuu fi waldaan tokko misooma jallisiif itti gaafat-amummaa fudhatee kan bulchu ta’ee, bu’uuraalee misooma jallisii fi qoorsa lafaa hammayyaa kan dabalatuudha.
 - 12) **“Miseensa”** jechuun nama miseensa waldaa itti fayyadamtoota bishaan jallisii ta’e jechuudha.
 - 13) **“Naannoo”** jechuun Naannoo Oromiyaa jechuudha.
 - 14) **“Nama”** jechuun nama uumamaa yookiin seeraan qaama seerummaa argate jechuudha.
 - 15) **“Qoorsa Lafaa”** jechuun bishaan biqiltuun barbaaduu ol ta’e ooyiruu keessaa baasuu jechuudha.
 - 16) **“Tajaajila Kennaa”** jechuun federeeshiniin alatti dhaabbata mootummaa yookiin dhuunfaa bu’uuraalee misooma jallisii fi qoorsa lafaa gurguddoo, giddu-galeessaa fi xixiqqaa kan bulchu, hojjetuu fi suphu jechuudha.
 - 17) **“Waldaa”** jechuun akkaataa Labsii kanaatiin kan gurmaa’ee fi kan galmaa’e Waldaa Itti Fayyadamtoota Bishaan Jallisii jechuudha.
3. **Ibsa Koorniyaa**
Labsii kana keessatti jechi koorniyaa dhiiraatiin ibsame dubartiis ni dabalata.
 4. **Daangaa Raawwatiinsaa**
Labsiin kun waldaalee akkaataa Labsii kanaatiin gurmaa’anii fi bu’uuraalee misoomaa fi qoorsa lafaa Naannicha keessatti argaman irratti raawwatiinsa ni qabaata.

- ፲፩) **“የውሃ አቅርቦት ምንጭ”** ማለት ውሃ የሚገኝበት ምንጭ እና አንድ ማኅበር ለመስኖ ስማት ጋሳፊነትን በመውሰድ የሚያስተዳድር ሆኖ፣ ዘመናዊ የመስኖ ስማት አውታር እና የመሬት ማንጣፈፍን የሚጨምር ነው።
- ፲፪) **“ክፍል”** ማለት የመስኖ ውሃ ተጠቃሚዎች ማኅበር አባል የሆነ ሰው ማለት ነው።
- ፲፫) **“ክልል”** ማለት የኦሮሚያ ክልል ነው።
- ፲፬) **“ክፍል”** ማለት የተፈጥሮ ወይም የሕግ ሰውነት የተሰጠው ማለት ነው።
- ፲፭) **“የመሬት ማንጣፈፍ”** ማለት አገልግሎት ከሚፈልገው በላይ የሆነውን ውሃ ከማሳ ውስጥ ማውጣት ማለት ነው።
- ፲፮) **“አገልግሎት ሰጪ”** ማለት ከፌዴሬሽን ወጪ የሆነ ትላልቅ፣ መካከለኛ እና ትናንሽ የስማት አውታሮችንና የመሬት ማንጣፈፍ ሥራን የሚያስተዳድር፣ የሚሰራ እና የሚጠግንበትን ሥራ ወይም የግል ድርጅት ማለት ነው።
- ፲፯) **“ማኅበር”** ማለት በዚህ አዋጅ መሠረት የተደራጀና የተመዘገበ የመስኖ ውሃ ተጠቃሚዎች ማኅበር ማለት ነው።

፫. የጾታ አገላለጽ

በዚህ አዋጅ ውስጥ በወንድ ጾታ የተገለጸው ሰትንም ይጨምራል።

፬. የተፈጻሚነት ወሰን

ይህ አዋጅ በዚህ አዋጅ መሠረት የተደራጁ ማኅበራትና የስማት አውታሮች እና በክልል ውስጥ በሚገኙ የመሬት ማንጣፈፍ ላይ ተፈጻሚነት ይኖራቸዋል።

9. **“Executive Committee”** means the body elected by the General Assembly to follow up and control the activities of an association.
10. **“Unit”** means a defined part of the service area of an association.
11. **“Source of Water Supply”** means a source at which an association takes responsibility to administer of water irrigation which includes irrigation development bases and land drainage.
12. **“Member”** means a person who is a member of irrigation water users association.
13. **“Region”** means Oromia Regional State.
14. **“Person”** means any natural or juridical person.
15. **“Land Drainage”** means to drain excess water from farm land which is beyond the necessity of crop.
16. **“Service Provider”** means any public or private enterprise, other than federation, which administer, operates and maintain of small, medium and large scale irrigation and land drainage.
17. **“Association”** means irrigation water users’ association established and registered in accordance with this Proclamation.

3. Gender Reference

In this proclamation, any reference in masculine gender shall include feminine gender.

4. Scope of Application

This Proclamation shall be applicable on all irrigation Water users association and drainage system established in the Region based on this proclamation.

Part Two**Objective and Basic Principles for
Establishment and Administra-
tion of Associations****5. Objective of the Association**

An association shall have the following objectives:-

- 1) Manage and administer an irrigation and drainage system in its service area generally or partially and Maintain, rejuvenate and improve and shall undertake construction and reconstruction works as it deems necessary;
- 2) Providing irrigation water distribution supply program in fairly basis for members within the area;
- 3) By strengthen environmental protection activity measures to combat flooding, salinity; and pollution in coordination with responsible bodies;
- 4) Train its members in irrigation techniques, irrigation farming methods, water saving methods and new technologies of irrigation;
- 5) Provide market information for its members; make agreement and coordination with legally authorized body for the provision of market outlets of irrigation products.

6. Basic Principles of Association

Any association shall work in accordance with the following guiding principles:-

- 1) Making Fairness in allocation of irrigation water to members;
- 2) Preventing wastage and pollution of water, avoiding erosion and salinity; irrigation and land drainage within the operation area so as to protect the environment;

7. Scope of service

Every Association shall:-

- 1) Working within defined scope of service;
- 2) Within defined scope of service an association shall comprise a distinct irrigation and land drainage Unit with a defined area of land that is capable of receiving irrigation water through the Irrigation and drainage system operated by that association from one or more water Supply points;
- 3) Scope of service of associations shall not overlap with each other.

8. General condition of establishment of an Association

- 1) A Person possessing land located in the service area of an association who have access to irrigation water and drainage system or who shall be accessed to irrigation water and land drainage and who have land use right in order to equitably utilize the available resources such as land, water and irrigation and drainage infrastructure, irrigation water users mandatorily shall establish Irrigation Water Users' Association;
- 2) Any established association shall be obtain permit from the Authority;
- 3) Any established association shall have written document of establishment and regulation to be approved by Oromia the Authority;
- 4) Any established association shall have:-
 - (a) Its own name;
 - (b) Administrative body;
 - (c) Objective for establishment of an association;

 - 8) The name of an association shall be written boldly and be placed where the association conducts its any activities; it shall also be written or stamped on every notice, letter, declarations or documents signed on behalf of the association.
- 9. As an Association be Established by Irrigation Development Authority**
- 1) Any established association shall be recognized by the Authority;
 - 2) An Authority shall be follow up the following procedure in establishment of an association:-
 - (a) Consultation with members of an association and concerning bodies;
 - (b) Organize founders committee to identify the service scope of the proposed association and also founders committee which may not exceed eleven potential members of the association;
 - (c) The founders committee shall be composed of persons representing different unit of the proposed service scope so as to ensure fair representation of potential members of the proposed association;

(b) Identifying service scope map that shows the location and size of the units;

(c) Preparing Application for the establishment of an association;

(d) Preparing the lists of documents of members those proposed association, which shall include the name, address, signature and description of land holding and land certificate number of each member if possible; and draft of work and budget plan.

2) Notwithstanding the provision of sub-article 1 (a-d) of this Article; the founders committee shall give opportunity for the members of an association to comment on the documents and provide to district authority;

Criteria of Membership shall be the followings:-

- 1) A person who is land owner which is located within the land scope of an association established in accordance with this Proclamation;
- 2) A person who acquired land which is located within the land scope of an association in succession or in any other legal way;
- 3) A person who uses right of the land on the basis of lease contract in accordance with Oromia Rural Land proclamation;
- 4) In accordance with sub-article 2 and 3 of this article; any person acquires use right of the land by succession or any other legal way and lease contract shall be considered as a member of the association until the agreement is terminated throughout the term of that lease and shall have the right to have right and responsibility of the members;
- 5) Without prejudice to sub-article 4 of this article; the lease taker has obligation to keep establishment memorandum and regulation of an association.

12. Terminating Membership

- 1) Any member who has ceases his use right over the land located within the service area of an association may terminate his membership, in written upon notifying to the association;

17. Registration Fee of Membership

An Association can collect registration fee during its establishment to cover its establishment cost.

18. Membership Contribution

1) An association shall collect fee from its members in proportion to the size of the plot of land of member in the service area to cover its costs;

2) The fee collected from membership shall be used for the purpose of:-

(a) To cover the costs of any operating and maintaining the irrigation and land drainage and the costs of cleaning any drainage ditches;

(b) To cover the costs of the service providers for the operation of the irrigation and drainage system or for those construct the irrigation canal or for the persons achieve the performance of the association;

(c) Pay salaries of the staffs and other costs of the association; and

(d) Maintain reserve fund for the association.

3) Members of an association which has small financial income may agree to make some or the entire annual membership fee to be paid in kind including contribution of labor.

19. **Water Service Payment Made by the Members of an Association**
Any association shall impose service payment on each member in proportion to the volume of irrigation water used or by the size of the plot of the land of that member. Its implementations determined in the regulation of the association.

Part Four

Control and Support System

20. Power of the Authority
Without prejudice to the power and duties vested to in the Authority by other laws; it shall have the following Power and duties;
- 1) Provide technical assistance and support to associations on water management, accounting, preparation of plan of work and budget of an association, irrigation techniques; experiences of maintenance, renew; repair and utilization of irrigation;
 - 2) Establish; Register; follow-up; monitor and support an association; take corrective measure; cause to be taken in accordance with this Proclamation;
 - 3) Audit asset of an association; cause to be audited by legally recognized body;
 - 4) Work for female, youth and hand cape of participation and utilization on irrigation development;
 - 5) The supervising body while exercising the legal and financial supervision of associations shall be limited to the activities of the association whether it comply with the provisions of this Proclamation and bylaw.

21. Reporting Procedure

- 1) Any association shall submit monthly and quarterly physical works, income and expenditure report of the association to the Authority by filling in the approved check list prepared for this purpose;
- 2) Any association shall submit an annual report to the Authority within 30 days as of each budget year ended, by filling in the approved check list prepared for this purpose; together with a copy of its accounts;
- 3) The annual assets, liabilities, income and expenditure statement of the association shall be approved by the general assembly every year.

22. Accounting and Property Control Procedure

- 1) The records of an association may be inspected in case of:-
 - (a) If there is claim from the members application in written or orally about incorrectness or illegal work or activities of the association;
 - (b) If there is evidence of legal or financial malpractice.
- 2) If the irrigation development Authority having inspected the records of an association finds evidence of financial malpractice or non-observance of the provisions of this Proclamation or the by-laws or internal regulations of the association, it may require the management committee to call an extraordinary meeting of the general assembly within 30 days to present the findings to the members;
- 3) If the management committee fails to call the meeting of the general assembly in accordance with sub-article (2) of this Article, the Authority itself may call such extraordinary meeting;

 - (d) Pledging the assets of an association for another issue;
 - (e) To initiate court case to cancel the water use right of a member the association shall have to get permission from an Authority in accordance with this Proclamation.
- 2) The monitoring body shall, pass decision on the applications submitted to obtain Authorization it in accordance with sub-article (1) of this Article, within the time Limit determined by a regulation issued to implement this Proclamation.

24. Registries to be owned by an Association

Any association has to have:-

- 1) A map showing the service area;
- 2) Registry of members, contain a description of the size and location of each member's landholding, and which shall be renewed in every three month as it deems necessary;
- 3) Registry the volume of water received or discharge by the association;
- 4) Registry describing the amount of water that members of irrigation water can obtain;

 - (c) Volume and location of the service area;
 - (d) Number of members;
 - (e) Name, address and telephone number of the members of the management Committee;
 - (f) Property of government owned infrastructure transferred to the association, if any;

26. Trans-Zone or District Boundary's Irrigation Water Users Associations

- 1) In the event that the service area of an association crosses the boundaries of two or more Zone within the regional state the Oromia Irrigation Development Authority shall be the monitoring body in respect of the establishment and operation of such Association;
- 2) In the event that the service area of an association crosses the boundaries of two or more District within the Zone the respective Zone Irrigation Development Authority shall be the monitoring body in respect of the establishment and operation of such Association;
- 3) With respect to medium and large scale irrigation projects the project offices shall be the monitoring body in respect of the formation and operation of such Association, in this regard Oromia Irrigation Development Authority shall provide necessary technical support.

Part Five

Dissolution and Liquidation of an Association

27. Dissolution of an Association

An association shall be dissolved where:-

- 1) The objective of its establishment is no longer exist; or
- 2) It is unable to implement the objective of its establishment; or
- 3) Its continuation is found unnecessary for any other reasons and the general assembly of an Association decided to be dissolved its 2/3 vote upon approval of the controlling body.

28. Liquidation of Financial Accounts of an Association

- 1) When the dissolution of an association has been decided in accordance with Article 27 of this Proclamation, the management committee or the supervising body shall assign liquidator or.
- 2) A liquidator assigned pursuant to sub-article (1) of this Article shall have the following powers and duties:
 - (a) Receive records, documents and properties of the association and protect them from damage;
 - (b) collect the assets and properties of the association;
 - (c) call on creditors of the association;
 - (d) distribute the assets in accordance with the decision of the general assembly which is approved by the supervising body;
 - (e) carry out necessary activities of the association for the proper liquidation of the affairs of the association;
 - (f) Represent the association in legal proceedings.
- 3) Until the dissolution is concluded, the provisions of this proclamation and the relevant by-laws and internal regulations of the association shall continue to apply to the association and its members.
- 4) The remuneration of liquidator shall be paid from the accounts of the association.

29. Cancellation of the Association from Registry

- 1) Upon conclusion of the liquidation process the supervising body shall cancel the registration of the association from the register of irrigation water users association.

The Associations may be organized in Federation; and their Power and Duties shall be determined bylaws of the Federation to be established.

Transferring Procedures of Irrigation Developments and Land Drainage to an Association and Service Delivered to Associations

31. Transferring Modern Irrigation Development Bases and Land Drainage

- 1) If the modern irrigation infrastructure and land drainage constructed or rehabilitated by the government or non-government organization found in irrigation water users association service area, use right shall be transferred to the association based on cost recovery procedures followed undertaken by the knowledge of the Authority and agreement with the association;
- 2) Every association can apply for modern irrigation and land drainage constructed by the government or non-government organization which is found in its service area for hand over for use right for indefinite period to the authority;
- 3) In the cases where the service area of an association lies in the water supply point of dam, weir, diversion structure, pump station or other type of infrastructure to which water is abstracted from a river, stream, reservoir, pond or other natural source such infrastructure may also be transferred to the association;

 - (b) The rights and duties of the parties to the agreement in terms of the maintenance of the infrastructure;
- 5) The infrastructure body shall in any event ensure the protection and maintenance of the parts of irrigation and drainage systems that are not transferred to any association and which remain under its control.

32. Payment of Members to Cover Costs

Collect the determined charge and refund to the Authority pursuant to the usage of water or the amount of irrigation land to be used with consideration of member's payment capacity of the association which discharge the investment cost applied for the medium and large modern irrigation and drainage construction.

33. Certificate for Traditional Irrigation Development Bases and Land Drainage

- 1) An association may apply to the appropriate infrastructure body to obtain use right certificate in respect of a traditional irrigation system that lies within its service area;
- 2) A use certificate shall contain major description of such traditional irrigation system and shall establish the right of the association to use that system.

34. Transferring Information and Technical Supervision

- 1) An association shall provide current information to the authority concerning the maintenance and condition of transferred irrigation and drainage system;
- 2) A duly authorized officer of the authority may enter into the service area of the association and inspect the condition of irrigation and drainage system transferred to it;
- 3) The officer of the the Authority body after having inspected and based upon the evidence gathered ;
 - (a) To prevent damage or harm to that infrastructure; or
 - (b) Can order different works To prevent damage to government property or the property of third parties.

35. Application to get Service on another Land

- 1) Every association shall be entitled to acquire servitude right over any one land necessary to rehabilitate or develop irrigation and drainage system for its members by submit the application to irrigation development Authority;
- 2) According to this article sub-article (1)the application provide to the irrigation development authority in collaboration with responsibly body approved payment of compensation to the land possessor in accordance with the law and can use the land.

36. About Service Providers

- 1) In the cases where the water supply point of the service area of an association of irrigation and drainage system that is not managed by a federation, the irrigation water and other related services shall be provided to an association by a service provider responsible for the operation and maintenance of the main irrigation and land drainage;
- 2) The conditions for the establishment of public enterprise or licensing private entities to provide the service shall be specified by regulations to be issued for the implementation of this Proclamation
- 3) A service provider shall provide irrigation water and other related services to an association on the basis of service agreement reached with the association.

37. About Agreement of Service Delivery

- 1) The term of every service agreement shall not be less than five years; provided, however, that by the request of the association it could be not less than two years, but in no case it shall be not more than five years;
- 2) Any service agreement shall made in standard format and include, in particular, the following:-
 - (a) Information of the water supply point;
 - (b) Season of the year in which irrigation water is to be supplied;
 - (c) The procedure for requesting water supply during the irrigation season;
 - (d) The maximum volume of water the association requires during each irrigation season in accordance with a monthly schedule, subject to any restriction on the service provider to supply such water by any appropriate body;
 - (e) Measures to be taken to reduce water wastage, pollution and salinity;

38. Amendment; Revocation or Cancellation of Service Agreement

- 1) The service agreement may be varied or amended by the agreement of both parties;
- 2) A service provider may suspend the supply of water and other services under service Agreement only if the association delays payment of any outstanding charges for more than 120 days;
- 3) A service agreement concluded in accordance with this Proclamation may be Terminated:-
 - (a) by the decision of the court of law when one of the parties persistently fail to comply with the terms of the agreement; or
 - (b) On the dissolution of the association.

39. Responsibility of Service Provider

- without prejudice to things specified under service agreement; service provider shall have the following responsibilities;
- 1) A service provider shall be liable to pay compensation equitable to the damage the association sustained due to his failure to supply water in the agreed quantity or in accordance with the time schedule;

- 2) Any member of an association who has sustained losses as a result of the inability of the service provider to provide irrigation water to the association shall be deemed to be a party to the contract for the purpose of calculating the amount of compensation to be claimed from the service provider;
- 3) Compensation shall not be payable in cases of force majeure as defined in the Civil Code of Ethiopia.

40. Responsibility of Service Receiver

- 1) The Association (service receiver) based on the agreement entered into conduct the service payment on time;
- 2) The Association (service receiver) based on the agreement conduct follow up and check works are conducted according to the agreement and provide any necessary support for the services provider.

41. Deciding Water Delivery Charges

- 1) The amount of charges payable by an association to a service provider for the delivery of water shall be determined based on the study by irrigation development authority;
- 2) In determining the amount charges payable to the service provider, the supervising body shall take into account:-
 - (a) The necessary reserve funds to be deposited for the maintenance;
 - (b) The ability of the members of the association to pay for irrigation water; and
 - (c) The service provider's reasonable benefit of investments. The implementation will be described on the implementation manual.

Part Seven**Dispute Settlement Procedure****42. Dispute Settlement Committee**

- 1) Every association shall have dispute settlement committee elected by the general assembly consisting of three up to five persons of high reputation and impartiality;
- 2) The term of office of a dispute settlement committee shall be three years; no member of such committee may be elected for more than two consecutive terms;
- 3) Members of a dispute settlement committee elected by the general assembly shall elect one of them to be the chairperson of the committee;
- 4) A member of the management committee may not at the same time serve as a member of the dispute settlement committee.

43. Power and Duties of Dispute Settlement Committee

- 1) The dispute settlement committee shall have the powers and duties to hear and determine:-
 - (a) Disputes on water use and distribution between members of the association;
 - (b) Is agreements related to the violation of the association's by-laws, or internal regulation;
 - (c) Matters related to non-observance of watering schedule and;
 - (d) Appeals lodged against the decision of the management committee.
- 2) Upon receiving complaint on the grounds specified under sub-article (1) of this Article, the dispute settlement committee shall:-
 - (a) Promptly inspect the source of the problem by the chairperson within five days from the day of appealing.

- (b) Akkaataa Keewwata kana Keewwata Xiqqaa 2 (a) tiin maddi iyyannoo yookiin komii falmichaa guyyaa qulqullaa'ee xumurame irraa eegalee guyyaa lama keessatti iyyannicha barreeffamaan nama himatame akka dhaqqabuu fi guyyaa beellamaa deebii isaa qabatee dhiyaachuun akka falmatu waraqaa waamichaa ni erga;
- (c) Dura taa'aan korichaa guyyaa waamichi himatamaa dhaqqabe irratti dhimmicha ilaaluuf miseensota koreetiif waamicha ni dabarsa;
- (d) Guyyaa beellamaa dhimmichi akka ilaalamu murtaa'e falmicha ni dhagaha; ragaawwan isaanii ni sakatta'a; barbaachisaa ta'ee yoo argame bakka ka'umsa falmichaatti argamuun dhimmicha ni qorata;
- (e) Guyyaa falmii dhagahe irraa eegalee guyyoota lama keessatti murtii kennuun wal-falmi-toota ni beeksisa.

- 1) Bu'uura Keewwata 43tiin murtiin koree waldhabiinsa hiikuun kenname hanga komiin irratti hin dhiyaannetti akkaataa seera hariiroo hawaasaatiin kan raawwatamu ta'a.
- 2) Murtii koree waldhabiinsa hiikuu irratti qaamni komii qabu guyyaa murtiin kenname irraa eegalee ji'a tokko keessatti Mana Murtii Aanaatti himannaa isaa dhiyeffachuun ni danda'a.

45. Adabbiiwwan Bulchiinsaa

To'annoo fi hordoffiin Abbaa Taayitaatiin taasifamu akkuma jirutti ta'ee, balleessaawwan armaan gaditti tarreeffaman miseensi kamiyyuu kan raawwate yoo ta'e, tarkaanfiiwwan bulchiinsaa waldichaan kan fudhatamu ta'a:

- (b) Where the allegation is lodged in writing, issue summon on the respondents so as to respond on the complaint and avail himself for the hearing;
- (c) The chairperson of the dispute settlement committee shall call the members of the committee to hear the issue within two days;
- (d) Hear both parties, examine their evidence or may undertake site inspections, if necessary;
- (e) Promptly announce its decision within two days after hearing.

44. Enforcement of Decision

- 1) Any decision or order made in accordance with this Proclamation of this Article 43 shall be considered as the decision of regular civil court and shall be executed unless reversed by appeal;
- 2) Any party dissatisfied with the decision of dispute settlement committee may lodge appeal to district court within one month starting from date of decision given.

Part Eight

Miscellaneous Provisions

45. Administrative Penalties

In addition to monitoring and evaluation right given to the authority the association may impose administrative sanctions against a member who fails to:

- 1) Miseensi kamiyyuu:

 - (d) Ta'e jedhee yookiin dagan-noodhaan qabeenya yookiin meeshaa waldichaa irratti yoo miidhaa geessisee fi baasii suphaa fi bakka buusuu kaffaluuf fedhii kan hin qabne yoo ta'e;
 - (e) Waa'ee lafa isaa fi haala itti fayyadama bishaan jallisii isaa waldichaaf ragaa sirrii ta'e kennuuf fedhii kan hin qabne yoo ta'e;
 - (f) Hojjettoota waldichaa yookiin namoota waldichaan ajajamanii akka barbachisummaa isaatti sarara jallisii hojii opireeshiinii fi suphaa gaggeesuudhaaf konkolaataa yookiin meeshaa ijaarsa misooma jallisii qabatanii deeman akka ooyiruu isaa keessa hin galle kan dhorke yoo ta'e; yookiin
 - (g) Dambiiwwan teekinikaa opireeshinii bu'uuraaalee misooma jallisii fi qoorsa lafaa ilaallatu kan darbe yoo ta'e, waldichi adabbii bulchiinsaa irratti murteessuu ni danda'a.
- 2) Gostii fi hanga adabbii Dambii ittiin bulmaata waldichaatiin kan murtaa'u ta'ee, adabbii ol'aanaan adabbii mallaqaa yookiin dhiyeesa bishaan misooma jallisii dabalatee tajaajila miseensichi argatu irraa dhaabuu ta'uu ni danda'a.
- 3) Addabbiin kan kennamu koree hojii raawachiiftuutiin ta'ee, ol'iyannoon koree falmii waldhabiinsa hiikuutti dhiyaachuu ni danda'a. Akkaataan raawwii isaa Dambii bahuun kan murtaa'u ta'a.

- 1) Every member shall be:-
 - (a) Observe the by-laws or any internal regulations adopted by the general assembly of the association;
 - (b) Pay timely any charges determined in accordance with the by-laws and this Proclamation or to provide labor service whenever necessary;
 - (c) Use irrigation water in accordance with the association's watering schedule;
 - (d) Pay the repair or replacement costs of any property or equipment of the association damaged as a result his negligent or intentional act;
 - (e) Provide relevant information to the association about his use of land or water;
 - (f) Allow employees or other persons ordered by the association to enter his land, with machines or equipment as necessary, in order to undertake works concerning the operation and maintenance of the irrigation system; and
 - (g) Comply with applicable technical rules concerning the operation of the irrigation and drainage system; the association can take administrative measures.
- 2) The type and amount of sanctions shall be specified in the by-laws or the internal regulations of each association and in particular it could be fine or the suspension of the provision of services including the supply of irrigation water.
- 3) A sanction shall be imposed by the management committee, and an appeal against such sanction may be submitted to a dispute settlement committee.

46. Dirqama Deeggarsa Kennuu

Qaamni kamiyyuu hojiirra oolmaa Labsii kanaatiif deeggarsa kennuuf dirqama ni qabaata.

47. Walqunnamtii Waldaaleen Qaamolee Bulchiinsaa Sadarkaan Jiran Waliin Qabaatan

- 1) Caasaaleen bulchiinsa Aanaa fi Gandaa waldaalee daangaa aangoo isaanii keessatti argamaniif bilisummaa hojimaata isaanii kabajuun sochii hojii isaaniitiif deeggarsa barbaachisu kennuufii qabu.
- 2) Daangaan tajaajila waldaa tokkoo uumama yaa'iinsa bishaanii hordofuun daangaa Bulchiinsa Godinaalee yookiin Aanaalee yookiin Gandaa naannichaa tokko irraa gara daangaa Bulchiinsaa Godinaalee yookiin Aanaalee yookiin Gandoota naannichaa birootti kan ce'u yoo ta'e, koreen tokko tokkoon qaama bulchiinsaa irraa miseensota bakka bu'aniin ijaarame dhimma waldicha ilaallatu irratti caasaalee bulchiinsaa waliin wal qunnamsiistuu ta'uun ni hojjetu.

Labsiin, Dambii, Qajeelfamoonnii fi barmaatileen hojii Labsii kanaan wal faallessan kamiyyuu dhimmoota Labsii kanaan hammataman irratti raawwatiinsa hin qabaatan.

46. Duty to Cooperate

Anybody shall have responsibility to cooperate for the implementation of this proclamation.

47. Relationship of Associations with Administrative of each Hierarchies.

- 1) District and Kebele officials shall provide support necessary for the formation and operation of associations within their jurisdiction by respecting their autonomy.
- 2) If the service area of the association transcends from one State, District or Kebele administration to another State, District or Kebele Administration following the natural flow of the river, there shall be delegated committee members from each administration to communicate the affairs of the association with the local administrations.

48. Transitional Provisions

Irrigation Water users Associations organized by in accordance with appropriate of other laws shall be made to reorganized with pursuant of this proclamation. Its implementation is determined by the regulation to be issued.

49. Inapplicable Laws

Any Proclamation, Regulation, Directives and Work practices inconsistent with this Proclamation shall not be applicable on matters covered by this proclamation.

- 1) Manni Maree Bulchiinsa Mootummaa Naannoo Oromiyaa Labsii kana raawwachiisuuf Dambii baasuu ni danda'a.
- 2) Abbaan Taayitichaa Labsii kanaa fi Dambii Labsii kana raawwachiisuuf bahu irratti Qajeelfama baasuu ni danda'a.

51. Yeroo Labsiin Kun Hojiirra Itti Oolu
Labsiin kun guyyaa Magalata Oromiyaa irratti maxxanfamee bahe irraa eegalee hojiirra kan oolu ta'a.

This Proclamation shall enter into force as of its publication on Megeleta Oromia.
